ORDER

As per the the Government Order read as Ist paper above Government have amended the qualification prescribed for the post of Principals in the educational institutions coming under Collegiate Education Department and Law Colleges subject to the amendment in Special Rules of the Collegiate Education Department as follows:

Associate Professor/Professor with the following qualifications are eligible for promotion as Principal:

- (i) Educational qualifications in the category of lecturer.
- (ii) Should possess Ph.D Degree in concerned /allied/relevant discipline.
- (iii) Should have a minimum period of 15 years of service in Collegiate Education Department.

The UGC as per the letter read as third paper above has informed that the teachers having a minimum of 10 years of teaching experience is eligible for promotion to the post of Principal in Training colleges. The Director of Collegiate Education as per the letter read as second paper above has reported that the existing vacancies in the Post of Principals in Government Training Colleges are not filled up due to the above mentioned discrepancy and therefore requested Government to modify the Government Order as per UGC regulations and NCTE norms and also recommended to include eligible Assisant Professor/Associate Professor/Professor as the feeder category for promotion to the post of Principal in Government Training College

Government have examined the matter in detail and in partial modification to the Government order read as Ist paper above , are pleased to order that Assistant Professor/Associate Professor/Professor with the above said qualifications with at least 10 years of teaching experience are eligible for promotion to the the post of Principal in Government Training Colleges under Collegiate Education Department.

The Government Order read as Ist paper above stands modified to the above extent and the existing Special Rules will be modified accordingly.
