### ORDER

As per the Government order read as 1<sup>st</sup> paper above, Administrative Sanction for an amount of Rs 9,00,00,000/- (Rupees Nine Crore only) was accorded to Thunchath Ezhuthachan Malayalam University from the H/A 2202-03-102-72(P) for the land acquisition at Vettam Village, Tirur Taluk, Malappuram District and directed to met balance amount through additional authorization.

As per the Government order read as 2<sup>nd</sup> paper above, Government released an amount of Rs.9,00,00,000/- (Rupees Nine Crore only) to Thunchath Ezhuthachan Malayalam University from the H/A 2202-03-102-72(P) for the purpose.

As per the letter read as 3<sup>rd</sup> above, the Vice Chancellor of Malayalam University furnished a proposal to Government for releasing the balance amount of rupees 764 lakhs towards the land acquisition of Thunchath Ezhuthachan Malayalam University.

As per the Government orders read as 4<sup>th</sup> and 5<sup>th</sup> paper above, Government additionally authorized an amount of Rs 1,75,76,000 /- (Rupees One Crore Seventy Five Lakh Seventy Six Thousand only) and Rs 3,05,89,000/- (Rupees Three Crore Five Lakh Eighty Nine Thousand only) through reappropriation, respectively to the H/A 2202-03-102-72-35 of Thunchath Ezhuthachan Malayalam University.

Government have examined the matter in detail and are pleased to release a total amount of Rs.7,64,00,000/- (Rupees Seven Crore Sixty Four Lakh only) (Rs 1,75,76,000 as additional authorisation +Rs 3,05,89,000 through reappropriation+ Rs 2,82,35,000 as current year Budget provision under Creation of Capital Assets) to Thunchath Ezhuthachan Malayalam University from the H/A 2202-03-102-72-35(P) towards the land acquisition at Vettam Village, Tirur Taluk, Malappuram District.

The amount will be transferred to the PSTSB Account No 799012700000055 of Thunchath Ezhuthachan Malayalam University.
