ORDER

Vide judgement in OP(KAT) No 151/2019 dated 15.07.2019 , High Court had directed Govt to appoint Dr. N.Vijayakumar to the post of Principal in Govt Engineering College, Barton Hill without prejudice to the question as to whether he is liable to be reverted which is pending consideration as OA 548/2019. Vide order of KAT, Thiruvananthapuram, in OA 770/2020, the respondents including Government, were directed to give posting to the applicant to the post of Principal in Govt Engineering College, Barton Hill within two weeks. Further, as per interim order dated 20.08.2020 in OP(KAT) 258/2020, High Court has again directed Govt to accommodate him (the 1st respondent) in the post of Principal

,Govt Engineering College ,Barton Hill within a period of one week from the date of receipt of copy of order.

In view of above court directions, Govt have examined the matter in detail and are pleased to appoint the 1st respondent, Dr. N.Vijayakumar, Principal , Govt Engineering College, Kannur Under orders of reversion as Professor , Govt Engineering College, (Kozhikode) provisionally in the post of Principal in Govt Engineering College, Barton Hill, Thiruvananthapuram, in the existing vacancy. The above appointment is subject to the final orders in the Original Petition.


The direction of the High Court and the Kerala Administrative Tribunal in the above cases are complied with accordingly.
