**ORDER**

Smt. Kalamol T K, Assistant Professor, Sree Krishna College, Guruvayur and three others have filed WPC No.21431/2015 seeking direction for payment of salary and other benefits. The petitioners were denied salary owing to another case ( WPC No.20018/2013 ) filed against the selection of the above candidates. The Hon. Court, as per Judgment read above, has dismissed WPC No.20018/2013 and directed to approve the appointment of the petitioners in WPC No.21431/2015 and to disburse salary and allowances due for them.

Government have examined the matter in detail and found that total workload of Malayalam in Sree Krishna College, Guruvayur is 76 hours and sanctioned posts are five. The petitioners were appointed against retirement vacancies and the University had approved their appointment on 24/02/2015 w.e.f. 03/06/2013. Later, Smt. Kalamol was relieved from the college on 09.06.2014. Therefore, Director of Collegiate Education and the Deputy Director of Collegiate Education, Thrissur are hereby directed to disburse pay and allowances due for the petitioners in WP(C) No.21431/2015 since the appointment of all the four petitioners were approved.

Moreover, Government have also found that Sree Krishna College, Guruvayur is eligible for only four posts for Malayalam based on workload ( 16 hours / week ) and hence sanctioned posts for Malayalam in Sree Krishna College, Guruvayur is hereby reduced to FOUR and it is specified that the College shall not make any appointment against the transfer of Smt.Kalamol on 9.6.2014.

The judgment dated 28.11.2019 of Honble High Court of Kerala in WP(C) No.21431/2015 is thus complied with.
