ORDER

As per Government Order read as 1st paper above, No Objection Certificate was issued to Markazu Ssaquafathi Ssunniyya, Kozhikode for starting a new self financing Law College in Kozhikode District for conducting LL.B 3 year and BBA LL.B 5 year courses during academic year 2013-14. The NOC was renewed in 2019-20 as per Government Order read as 2nd paper above.

2.The General Secretary, Markazu Ssaquafathi Ssunniyya, Kozhikode as per the letter read as 4th paper above requested to revalidate the NOC already issued to the Educational Agency for conducting LLB 3 year and BBA LLB 5 year courses for the Academic year 2020-21 also. The University of Calicut has extended the provisional affiliation for the year 2019-20 as per the U.O. read as 3rd paper above. The Educational Agency as per the reference 5th above has executed a fresh agreement with Government agreeing to abide by the terms and conditions prescribed in the original agreement and the rules and orders issued by Government from time to time.

3. In the above circumstances, Government are pleased to renew the No Objection Certificate issued to Markaz Law College at Kaithapoyil, Kozhikode for conducting 3 year LL.B (50 seats) and 5 year BBA LL.B Courses (60 seats) for the academic year 2020-21, subject to the following conditions:

- 1) The college shall seek NAAC accreditation by 2021
- 2)The college shall appoint faculties who are qualified as per rules including NET, as

applicable.

4. The Management shall conduct only the courses for which approval /affiliation has been received subject to the fulfillment of the conditions in the Agreement and Undertaking already executed by them with Government.

5. Government also order that the admission of students and commencement of classes by the college shall be made only in accordance with the rules and regulations of the University and Bar Council of India.
